- a) A Resolution To Canvass The Election Results For The General Election Held On May 7, 2022 For The Purpose Of Electing The Mayor, Council Place Two, Council Place Four, And Council Place Six.
- b) A Resolution To Canvass The Election Results For The Bond Election Held On May 7, 2022 For The Purpose Of Presenting Three (3) Bond Propositions Regarding The Issuance Of General Obligation Bonds:

- i) PROPOSITION A The Issuance Of \$86,600,000 Bonds By The City Of Cedar Park, Texas, For Transportation Improvements And Facilities To Include Streets, Sidewalks, Pathways, Bike And Pedestrian System Improvements, And Other Transportation Facilities.
- ii) PROPOSITION B The Issuance of \$42,200,000 Bonds By The City Of Cedar Park, Texas, For Parks, Recreational Facilities, Trails, Open Space Improvements And Projects.
- iii) PROPOSITION C The Issuance Of \$30,000,000 Bonds By The City Of Cedar Park, Texas, For Public Safety Facilities For Police And Fire Protection, Including Training Facilities.

# 3) Adjournment.

At the discretion of the City Council, non-agenda items under the headings of "Citizen Communications" may be presented to the Council for informational purposes; however, by law, the Council shall not discuss, deliberate or vote upon such matters except that a statement of specific factual information, a recitation of existing policy, and deliberations concerning the placing of the subject on a subsequent agenda may take place.
